To ensure the safety and security of all participants, The Hub has implemented the following policies:

- a. **Respect** - Yourself, Others, The Hub (and all the facilities)
- b. **Speak** - Positively, With Kindness, Truth, Respectfully
- c. **Act** - Appropriate Behavior is Expected (No Excessive Public Displays of Affection)
- d. **Safe** - Zero Tolerance for Drug Use, Alcohol, Bullying/Harassment, Physical Altercations
- e. **Clean** -Put Things Away, Clean Up After Yourself
- f. **Non-Smoking** - No Smoking or Vaping in or near The Hub

The Hub will focus on discipline, reconciliation, and natural consequences. The Hub will encourage youth to understand why a consequence is taking place and how to right the wrong they have done. The following protocol will be followed:

1. First Infraction: Verbal warning and explanation will be provided.
2. Second Infraction: Removed from the activity they are involved in for a reasonable amount of time.
3. Third Infraction: Told to leave The Hub for the remainder of the evening.

\* If a concern that the incident justifies the youth being away from The Hub for an extended period of time, this will be addressed with the Director. In such a case the parent/guardian will also be informed.

\*\*Any leader can ask a youth to leave The Hub if they determine that they are acting inappropriately or compromising safety.

**Parents are notified for the following reasons:** A youth is asked to leave The Hub, all injuries, a youth is found to be under the influence of drugs or alcohol, any other incident deemed necessary to maintain the health and safety of everyone.

**The police are called for the following reasons:** Physical altercations, theft, any drug or alcohol involvement, any cases of harassment, any instance that threatens the health and safety of anyone.

**Media Agreement:** Online Content is not rated. I understand that it is not always possible to be aware of everything contained within online content. I understand that I expected to make every reasonable effort to access and play only appropriate content. Excessive swearing, explicit sexual content and drug reference is prohibited. Non-edited music (versions) must not violate these restrictions. Clean or radio edits of songs are required when available. [\_\_\_\_] ← initial here
